**Registration fee** is once only payment, payable on enrolment and non-refundable.

**Tuition fee** may be paid annually or termly (four times each year), before the commencement of each term. Tuition fees for mid-year enrolment will be calculated based on the number of weeks remaining in the term. Partial weeks will be counted as full weeks. **Due dates for tuition fee: Term 1 – 15 August, Term 2 – 15 November, Term 3 – 31 January, Term 4 – 15 April.**

A limited number of **scholarships** are available for students. Only Slovak citizens can apply for a scholarship (at least one parent or child must have Slovak citizenship).

**Scholarship with contract period** will be awarded only if applicant accept below mentioned conditions :

- 2 years contract in Education Agreement,
- provision of personal references/testimonials in KEIS marketing communication (website, school video and other marketing tools)
- registration fee paid until 30<sup>th</sup> of April 2021
- at least one of the parents and/or child must have Slovak citizenship.

No other discounts are available for Scholarship with contract period.

**Discounts** are applicable for standard tuition fee without the scholarship.

**Annual Discount** is available given school fees are fully paid for the whole academic year. In order to apply for annual discount, the full payment must be made **by 15<sup>th</sup> August 2021.**
