The tuition fee may be paid annually or termly (four times each year), before the commencement of each term. Tuition fees for mid-year enrolment will be calculated based on the number of weeks remaining in the term. Partial weeks will be counted as full weeks. **Due dates for tuition fee: Term 1 – 15 August, Term 2 – 15 November, Term 3 – 31 January, Term 4 – 15 April.**

SCHOLARSHIP AND DISCOUNTS

¹**Scholarship with a contract period** will be awarded only if the applicant accepts the below-mentioned conditions:

- a) 2 years contract in Education Agreement,
- b) provision of personal references/testimonials, right to use a picture of the student in KEIS marketing communication (website, school video, and other marketing tools)
- c) at least one of the parents and/or child must have Slovak citizenship.

²A limited number of **scholarships** are available for students. Only Slovak citizens can apply for a scholarship (at least one parent or child must have Slovak citizenship).

No other discounts are available for Scholarships with a contract period.
